Note: It is the responsibility of the bidder to make sure the bid is delivered to the address listed above. Please be informed that UPS does not deliver directly to this physical address.

# **BID SECURITY:**

Bid proposals shall be accompanied by a certified or cashier's check or bid bond for an amount not less than ten percent (10%) of the bid amount, payable to the District. A bid bond shall be secured from an admitted surety company, licensed in the State of California, and satisfactory to the District.

# **BOND REQUIREMENTS:**

The successful bidder shall be required to submit payment and performance bonds as specified in and using the bond forms included with the Contract Documents. All required bonds shall be based on the maximum total contract price as awarded, including additive alternates, if applicable. Payment and performance bonds shall be based on 100% of the contract price.

## **PROJECT ESTIMATE:**

The project estimate is \$140,000 to \$150,000.
